INSTRUCTIONS

- 1. Prior to submitting your Operating Permit Application to the JOGA, you must first receive a Gross Receipts Tax clearance letter from the Jicarilla Revenue & Taxation Department. An Operating Permit will not be processed without required documentation.
- 2. Submit completed Operating Permit Application to the JOGA (see requirements below).
- 3. Submit a check, money order, or cashier's check to the JOGA made out to the Jicarilla Apache Nation. Annual costs are \$1,000.00 for a Permit. Vehicle stickers a fee of \$20.00 each for the first 20 stickers, a fee of \$10.00 each for the next 80 stickers, and \$5.00 each above 100 stickers purchased.
 - a. NOTE CREDIT/DEBIT CARDS AND/OR CASH ARE NOT ACCEPTED
- 4. Appointments are necessary for new companies only.
- 5. Receive Operating Permit and vehicle stickers from JOGA. You may either pick them up in person or have them mailed to you. A copy of the permit will be carried with you at all times when on the Nation's Lands. A vehicle sticker will be placed in a visible location on each vehicle, preferably on the windshield. Vehicles include trucks, graders, backhoes, ATV's, etc.
- 6. Obtain Work Permits from the Jicarilla Department of Labor for all employees who will conduct business activities on the Jicarilla Apache Nation.

REQUIREMENTS

- 1. The Operating Permit Application packet must include;
 - a. Clearance letter from the Jicarilla Revenue & Taxation Department.
 - b. Completed and signed Operating Permit Application.
 - c. For a permit renewal, include a copy of the current or most recent Operating Permit.
 - d. Proof of bond or insurance in the amount of \$1,000,000.00 USD. Contact your insurance company and make the Jicarilla Apache Nation the certificate holder.
 - e. A brief statement stating;
 - i. Past oil and gas business activities including locations, type or operations, and business names
 - ii. Description of business activity to be conducted,
 - iii. List the oil and gas companies with whom you will be doing business,
 - iv. Provide location(s) where business activities will be conducted.
 - f. For corporations, limited liability companies, or other business entities, provide;
 - i. A copy of the corporate charter or other organizational documentation,
 - ii. A copy of the document authorizing the business entity to conduct business in the State of New Mexico,
 - iii. Provide documentation describing all subsidiary and parent entities.
 - g. List of all employees that will conduct business on the Jicarilla Apache Nation.
 - h. List of all vehicles that will be used to conduct business on the Jicarilla Apache Nation.

NOTICES

AUTHORITY: JANC Title 18 - Oil & Gas, JANC Title 11 - Taxation, and JANC Title 23 - Indian Preference.

The terms of this permit is one year renewable; this authority DOES NOT allow for day, week, temporary, otherwise. The company is solely responsible for renewing their Operating Permit in a timely manner.

PRINCIPAL PURPOSE: No person shall engage in any oil and gas activity within the Nation without first obtaining and maintaining in good standing an oil and gas Operating Permit. The intent of this permit is to control access to the Nation, other than those allowed through State or Federal highways and other rights-of-ways, and for the purpose of managing the natural resources of the Jicarilla Apache Nation, environmental conservation, public safety, and eliminating illegal trespass.

EFFECT OF NOT PROVIDING THIS INFORMATION: If you do not furnish all the information required by this form, your application may be rejected.

ROUTINE USES:

The JOGA collects this information to monitor and enforce access to and activities on the Jicarilla Apache Nation.

The JOGA is collecting this information to process your application and affect a binding permit.

The JOGA will use this information to identify and communicate with applicants.
